Contract

By enrolling your dog into our daycare program, you are agreeing to the following terms and conditions. Please initial each line and sign at the bottom.

1. I understand that I am responsible for any harm caused by my dog while my dog is attending Pabby's. I shall indemnify Pabby's against any claims made against the corporation or losses or damages of any kind suffered by Pabby's as a result of my failure to inform Pabby's of any pre-existing condition the dog may have (such as illness or aggression problems.) I understand and agree that in admitting my dog to Pabby's, the facility has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog. _____
2. I understand and agree that Pabby's will not be liable for problems, damage, or injury caused by my dog provided reasonable care and precautions are followed by staff. I understand that Pabby's is fully insured. I release Pabby's of any liability arising from my dog's attendance and participation at the daycare. I understand that the daycare is a place where animals co-mingle in groups and there is related risk to this environment. _____
3. I understand my animal may be placed in a crate for breaks not to exceed twenty minutes or if injured. In extreme cases dogs may be placed in a gentle leader or muzzled for their protection or the protection of others or for excessive barking. _____

4. I understand that when dogs play in groups, nicks and scratches may occur. If the injury is not serious, staff will make a judgment call and may feel it is okay to leave the dog until the end of the day and let me know about it when I pick up. If the injury is serious I will be notified immediately. _____

5. I understand and agree that any problem or injury that develops with my dog will be treated as deemed best by Pabby's. Central Vet or Circle of Life Veterinary facilities will be contacted if I am unavailable in the event of a medical problem that is serious in nature. _____

6. I understand that if my dog is left at the daycare for a period of one day without contact from the owner this dog will be considered abandoned and necessary steps will be taken to turn the animal over to the proper authorities. _____

7. I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to, injuries resulting from rough play, kennel cough & other communicable diseases, and fatigue for adjusting daycare dogs. _____

8. I, as the owner, agree to be solely responsible for any and all acts or behavior or my pet while in the care of Pabby's. If my pet should become ill or seem to be in need of medical consideration, Pabby's reserves the right to administer aid and/or to use any available veterinarian. I, the owner, shall pay any expenses so incurred as long as reasonable care and precaution has been used by our staff. _____

9. I understand that Pabby's reserves the right to do the following: deny entry to our program if my dog is not deemed a good candidate for daycare, reschedule my interview if my dog is deemed a potential good candidate who needs another evaluation, or remove my dog from our program after acceptance if their behavior grows to be unacceptable or unsafe for our staff members and for the other daycare dogs. _____

10. I understand that I am to keep my dog home if they are feeling unwell, and/or presenting with potentially communicable diseases and illnesses. This includes but is not limited to coughing, diarrhea and general stomach upset, recent seizures, or unusual changes in behavior. I understand that if I am not forthcoming with Pabby's and bring my dog to daycare, that I am putting both my own dog and other daycare dogs at risk for illness or injury. I understand that I will both be held liable for the resulting consequences of bringing my dog to daycare and face termination from the daycare program. _____

11. I understand that I will require written proof of health from my veterinarian before my dog can return to daycare after being diagnosed with a serious injury or a communicable illness. I understand that the seriousness of an injury in regards to my dog's future safety at daycare is up to the discretion of Pabby's. _____

12. I understand that daycare days need to be reserved in advance, and I cannot drop my dog off on days that I have not reserved. I understand that Pabby's will not take dogs without a reservation for both daycare and boarding. _____
